- 2. Explanation of the change in profit after corporate income tax in the Statement of Profit and Loss for the reporting period when it varies by 10% or more compared to the same period of the previous year:
- The profit after tax in 2024 was VND 855.72 billion.
- The profit after tax in 2023 was VND 515.16 billion.

The profit after tax in 2024 increased by VND 340.56 billion, equivalent to a 66% rise compared to 2023. The main reasons are as follows: In 2024, financial expenses decreased by VND 184.39 billion due to lower interest expenses; profit from associates increased significantly by VND 135.3 billion. Although revenue slightly declined, the consolidated gross profit margin on net revenue in 2024 reached 23.4%, compared to 21% in the same period of 2023. This improvement was driven by slightly lower input costs and better performance of power plants compared to the previous year, resulting in a substantial increase in profit for the year.

- 3. Explanation of the difference in profit after tax in 2024 before and after the audit when the variance is 5% or more:
- The profit after tax in 2024 before the audit was VND 943.7 billion.
- The profit after tax in 2024 after the audit was VND 855.72 billion.

In the 2024 consolidated financial statements, the profit after tax after the audit decreased compared to the accumulated figures in the Q4/2024 financial

statements due to changes in the results of a subsidiary. The consolidated report of the Corporation after the audit led to a decrease in business performance compared to the accumulated figures previously reported in the Q4/2024 financial statements.
